PARTICIPANTS ARE PROVIDED A 5-DAY SUPPLY OF FOOD BASED UPON THE NUMBER IN THE HOUSEHOLD, TYPICALLY ONCE PER MONTH. PROP ALSO HAS A PANTRY AREA THAT OFFERS FRESH PRODUCE, BAKERY ITEMS AND OTHER PERISHABLES. CLIENTS CAN ACCESS THE PANTRY ONCE EACH WEEK.
